Notice Bi-Monthly Meeting Board of Trustees

Financial Information – June 30, 2022

\$30,496 expenditures were lower than \$60,485 revenues for +\$29,990 surplus, which increased operating cash to \$273,029. Revenues exceed budget by \$3,776 due to +\$2,520 sales taxes and \$656 ARPA funds. Expenditures are \$36,119 below budget due to \$29,400 lower expenses for consulting for issues related to 44th street Joplin construction/water issues (see comments in section about 44th and Connecticut). The replacement of barrier with gate cost \$3,776 (-\$1,224 versus budget). As a result, YTD surplus is \$39,896 higher than budget. Balances in bank accounts are \$341,788 with \$96,128 (checking/operating), \$97,758 (money market/savings), \$79,143 (sales tax account) and the American Rescue Plan Act (ARPA) fund of \$68,759.

American Rescue Plan Act (ARPA)

Leawood received \$68,759. Previously the funds use was restricted to specific areas including "support vital wastewater and storm water infrastructure". The required compliance reports for ARPA due on April 30th were filed. In a recent update the Treasury has provided more flexibility for spending the \$68,759 to include the broad category of "government services". Uses will be discussed at July meeting and then discussed with our attorney to ensure compliance.

Zoning Ordinance Adopted

Ordinance NO. 2022-2 for Adopting the Zoning Map from the 2014 Comprehensive Plan was approved at the trustee meeting on May 19th and will be filed with the Recorder of Deeds of Newton County. This is necessary due a misunderstanding that even though the 2014 Comprehensive Plan was filed that included 2014 Zoning Map. It was necessary to pass and file a separate Ordinance.

44th and Connecticut

Due to concerns about the existing and potential water run-off from this project and potential developments, earlier this year a hydro-engineer from Columbia MO was retained to conduct a site review and review the City of Joplin's details for the project.

A memorandum of the review was prepared and forwarded to Joplin in early April. The memorandum indicated that: (1) The consultants for Joplin "determined on the 25-year design storm analysis the peak discharge rate for the proposed condition increased by approximately 8%" and (2) Our consultant indicated that "the peak discharge rate for the proposed condition increased by approximately 50%". The memorandum further stated, "Discharging seventy-five ft³/s from the 3 ft. wide culvert **without a detention or energy dissipation structure(s) is causing and will continue to cause major erosion damage downstream**". Our consultant and two trustees met with Joplin officials and their consultants on May 10th to discuss the memorandum. At Joplin's request details of the consultant's "model input file" was provided by the consultant on May 23rd. Joplin has not responded.

Leawood signed an Engineering Service Agreement with Hydro-Engineers LLC for \$39,500 to \$46,500 to address the specific issues of the design plans by Joplin. YTD \$10,620 has been spent with a \$1,651 pending bill. \$40,000 was budgeted.

Franchise Tax Rate

Liberty/Empire passed a 7.6% rate increase effective August 1st. When such % increases exceed 7% Missouri Statutes require the municipalities pass an ordinance to reaffirm/preserve their existing rate (4.0% for Leawood). The total annual increase is \$1,918.51. If the ordinance is not passed the rate would decrease to 3.73%.
